Background information

Today, corruption, misgovernance, and human rights violations by public officials, private business sector - and even citizens - are among the biggest threats to reducing poverty and promoting shared prosperity.

Corruption hurts the poor disproportionately and hinders efforts to achieve the sustainable development goals (SDGs), poverty eradication and human development. More specifically, self-dealing, and illicit money derived from corruption are further weakening economies, inequality, and stifling development, especially in emerging nations, thereby stifling growth and the effective functioning of the rule of law.

To address these challenges, governments, international organizations, civil societies, and other stakeholders must develop and implement public policies that are inclusive, multidimensional, and accountability throughout ensuring equal application and enforcement of the laws.
